ELIGIBILITY

Open to all New Jersey, Pennsylvania and Delaware residents, 18 years and older.

RULES OF ENTRY

Both film and digital capture, with any type camera or film is allowed. Work may be traditional photographic prints or high quality digital prints.

Work must be framed, wired and ready to hang. No clip frames or center hangers. Mats and glass must be clean and frames in good condition or they will not be accepted for exhibit. Work previously hung in a juried show at Smithville Mansion will not be accepted.

Limit 3 pieces. Work selected must remain on display until the end of the exhibit.

FEE

A \$20.00 non-refundable entry fee per artist. Make checks payable to: **Treasurer, Burlington County**. The Division of Cultural Affairs and Tourism requests a 20% donation on the sale of exhibited works.
