Nudes will not be accepted. Work previously shown at past WAA Open Juried Annuals will not be eligible.

ENTRY FEES: \$12.00 for WAA members. \$20.00 for non-members. Make checks payable to Willingboro Art Alliance. Membership at registration: \$20.00 through 2009. **Gallery commission is 30% on all sales.** Sales tax is paid by buyer.

REGISTRATION: Complete the registration forms, attach labels to art work. To be notified of juror results, provide a Self Addressed Stamped Envelope (SASE).

GUIDELINES: Submission to this exhibition is an agreement on the part of the entering artist to all of the conditions set forth in this prospectus. All work must be original, created SOLELY by the artist, no reproductions. Art works should be properly framed and wired for hanging, and may not exceed 40 inches in any direction, including frame. No accepted art may be removed before December 8th.

From North Jersey:

Take 295 South to Exit 40 - Route 38 East (Mt. Holly). Proceed 6 miles to Route 691 (Madison Avenue). Take the jug handle, cross over Route 38 follow the hospital signs. Hospital is two blocks off Route 38 on the right-hand side.

From South Jersey:

Take 295 North to Exit 40A - Route 38 East (Mt. Holly). Proceed 6 miles to Route 691. Take the jug handle, cross over Route 38, follow hospital signs. Hospital is two blocks off Route 38 on right-hand side.

From Walt Whitman Bridge:

Follow signs for 295 North. Take Trenton Exit and continue North on 295 to Exit 40A (Route 38). Follow directions from South Jersey.

From Ben Franklin Bridge:

Exit toll area and stay to far left. Take Route 30 East (Cherry Hill) to Route 38. Stay on Route 38 East approximately 16 miles to Route 691 (Madison Avenue). Take the jug handle, cross over Route 38 following the hospital signs. Hospital is two blocks off Route 38 on the right-hand side.

Bus Routes:

**Route 413 stops at the hospital.
Routes 317 and 413 stop at Washington Street and Madison Avenue. For directions from your home, contact New Jersey Transit [online](#) or by phone (800-772-2222).**

The hospital offers free valet parking. The Dr. David Flinker Pavilion Art Gallery is located on the First Floor of the Hospital. You will enter at the Ground Level, get a pass from the information desk and then can take either set of elevators to Level 1.
